## CART STORAGE REGULATIONS and PRIVATELY-OWNED CART USE

### **Private Cart Storage Regulations**

(I) Authorization to store a private cart in the HHCC storage facility must be approved by the Board of Directors or its designee, prior to use. Trail Fee must be paid in full at the time of application.

(2) There is waiting list in the clubhouse for On-Course storage. Authorization to store a private cart will be determined on a first-come, first-serve basis from these lists. You will be notified of your eligibility when your name comes to the top of the list. Only one cart per member is permitted, unless otherwise authorized by the Board. (3) If approval to store a private cart on course is given after July 1, the Trail fee charged will be prorated from the time permission is granted until the last day of February of the next year. If permission is granted prior to July I, the full Trail Fee will be due.

(4) Private cart privileges are not transferrable.

(5) All Trail Fees expire on the last day of February. If the appropriate fee is not paid by March I, the member is assumed to have forfeited his/her cart privileges. The first person on the appropriate waiting list will he notified and will have five (5) days to accept or reject the opening. After (5) days, or upon rejection the next person on the list will be notified. There will be no exceptions to the above and partial payments are not permitted,

(6) Trail fees are refundable on a pro-rated basis per 365-day year, relative to October 31th, at the discretion of the Board of Directors. There will be no refund given after October 31st.

(7) Proof of **current** liability insurance coverage in the amount of \$100,000 is <u>required</u> prior to storage and usage.

(8) Trail Fees, **associated with private carts stored on property**, permit two (2) designated drivers, provided both are listed on the Membership Application and 16 years of age. Additional operators may be added for **\$75.00**, provide they are listed on the same membership application.

(9) Carts are to be maintained with respect to proper appearance and working order and must be operated in accordance with HHCC rules and regulations and instructions provided through the staff.

(10) Cart owners will be responsible for the upkeep of their assigned space this includes picking up trash and not storing any cart parts or golfing equipment within your assigned space.

(11) If the Board of Directors feels it has just cause, it may revoke a member's cart privilege by refunding the Trail Fee, pro-rated through October 31st.

(12) <u>Winter storage only</u> may be approved, at a pro-rated cost, provided space is available

### <u>Privately Owned Golf Carts</u>

Members and other persons, as designated by the Board of Director's, residing off property and wishing to use a privately-owned cart on the grounds of HHCC, will be required to pay an annual Trail Fee, as set forth by the Board of Director's and comply with both (7) and (9) of the above regulations. **Effective in 2020**, persons wishing to use multiple privately-owned carts on the grounds of HHCC will be assessed a fee, as set forth by the Board of Director's, for each additional cart.

#### Seasonal HHCC Cart Rental

A member of HHCC may pay a Trail Fee, as set forth by the Board of Director's for the seasonal use of a HHCC owned cart. The number of HHCC owned carts available for seasonal rental may be limited. HHCC <u>cannot</u> guarantee however, that a cart will be available at the time and day a person wishes to use it. The Trail Fee permits one operator to use the HHCC owned cart throughout the season (April-October). An additional operator may be added for \$75.00, provided they are listed on the same membership application. The operator(s) must be 16 years of age or older and comply with all rules governing the use and operation of carts. Under no circumstance may an HHCC owned golf cart leave the premises.

Failure to comply with the HHCC above rules may result in the forfeiture of cart privileges.
